Wave 1 Small Grants: This first wave of funding from the collaboration of funders is for urgent needs so that you can cover costs that you are incurring right now to support communities affected by the covid-19 outbreak and the move to social distancing, with a focus on food and essentials. Groups have told us that they are incurring additional expenditure to meet short-term needs around food and essential items such as mobile phones, data and cleaning products in these initial weeks. This funding is intended to enable you to cover these essential and urgent costs so that you can carry on providing support to Londoners. You can apply now for a grant up to £5,000 for these immediate and urgent needs. A larger fund will become available in April larger grants, service transformation costs, and ongoing work to support communities. And you can apply for both.
